This agreement is made and entered into the 1<sup>st</sup> day of January, 2023, by and between the Kentucky Educational Development Corporation (KEDC), 904 Rose Road, Ashland, KY 41102-7104, and Commonwealth Technology & Solutions of KY, LLC, 1086 Carry Nation Road, Lancaster, KY 40444. KEDC is an educational cooperative organized under the Interlocal Cooperation Act and providing various services to its member school districts. KEDC is also acting as fiscal agent for all KPC members.

The original agreement is set to expire on December 31, 2022, with KEDC reserving the right for one-year extensions as permitted by Kentucky Model Procurement Code, KRS Chapter 45A. This agreement represents an extension for an additional year from January 01, 2023 and will expire on December 31, 2023.

This agreement incorporates the CLS2022 Terms and Conditions, amendments, and Commonwealth Technology & Solutions of KY, LLC's Response by reference. Submitted deviations or exceptions to the terms and conditions were not accepted. This is a fixed percentage discount bid with the minimum discount being fixed for the term of that contract at the rate below.

Administrative Fee section paragraph addition, Adopted 01/01/2023

Accounts more than 21 days past due are subject to account suspension. Suspended accounts must be brought current and are subject to the reinstatement fee to have their contract restored. Accounts more than 90 days past due are subject to termination and may be precluded from participation with KPC for one year.
