

AGREEMENT BETWEEN THE  
KENTUCKY EDUCATIONAL DEVELOPMENT CORPORATION  
AND

WILLIAM V. MACGILL AND CO./MACGILL SCHOOL NURSE SUPPLIES

This agreement is made and entered into the 1<sup>st</sup> day of January, 2023, by and between the Kentucky Educational Development Corporation (KEDC), 904 Rose Road, Ashland, KY 41102-7104, and William V. MacGill and Co./MacGill School Nurse Supplies, 1000 N Lombard Road, Lombard, IL 60148. KEDC is an educational cooperative organized under the Interlocal Cooperation Act and providing various services to its member school districts. KEDC is also acting as fiscal agent for all KPC members.

The original agreement is set to expire on December 31, 2022, with KEDC reserving the right for one-year extensions as permitted by Kentucky Model Procurement Code, KRS Chapter 45A. This agreement represents an extension for an additional year from January 01, 2023 and will expire on December 31, 2023.

This agreement incorporates the CLS2022 Terms and Conditions, amendments, and William V. MacGill and Co./MacGill School Nurse Supplies's Response by reference. Submitted deviations or exceptions to the terms and conditions were not accepted. This is a fixed percentage discount bid with the minimum discount being fixed for the term of that contract at the rate below.
